<b>Funding Priority:</b>	<p>CHI Memorial’s Community Health Needs Assessment defined the following Funding Priority items; each application for funding is reviewed to determine how it addresses...</p> <p>...Poverty/Security, Access to Health Care, Transportation, Children’s Health, Obesity, Health Education, Obesity, Health Education, Disease Management, Behavioral Health, and/or Substance Use/Abuse.</p>
<b>Funding Restrictions:</b>	<p>CHI Memorial will not provide Community Benefit funding to...</p> <p>...individuals, endowments, or deficit spending.</p> <p>...capital campaigns or political candidates/campaigns/caucuses/PACs.</p> <p>...private clubs or private schools (except Catholic Schools as part of a shared Catholic Identity).</p> <p>...organizations without a non-profit status as defined by the IRS.</p>

...sports facilities, sports teams, or organized athletic events including golf tournaments.

...special-occasion or commemorative advertising (unless part of a health-related sponsorship).
